RE: State Assessments

Periodically, HPI sends our clients and brokers an update of the fees assessed by the various states. The chart below summarizes the information on state assessments as of July 2024, showing how they are calculated – either based on members in the specific state or claims paid within the state – and when they are effective.

- HPI collects these amounts and remits them to the applicable jurisdictions on behalf of our clients.
- The assessments applicable to each client are shown on that client’s *Claims Awaiting Funding Report*. Each assessment can be identified by its Funding Report Code.
